OUR ANCHOR INSTITUTION PROGRAM CONTINUED TO CARRY OUT RESEARCH AND ASSESSMENT OF THE ROLE UNIVERSITIES, HOSPITALS, COMMUNITY FOUNDATIONS AND OTHER PLACE-BASED ANCHORS PLAY IN EXPANDING OPPORTUNITY FOR THEIR COMMUNITY AND ITS RESIDENTS. THROUGH OUR NATIONAL HEALTHCARE ANCHOR NETWORK INITIATIVE, WE DEEPEDED ENGAGEMENT WITH NONPROFIT HEALTHCARE LEADERS AT APPROXIMATELY 60 HEALTH SYSTEMS TO HELP THESE SYSTEMS USE THEIR HIRING, PURCHASING AND INVESTING POWER TO IMPROVE THE HEALTH AND WELLBEING OF UNDER-SERVED COMMUNITIES AND COMMUNITIES OF COLOR.
