THROUGH OUR COMMUNITY WEALTH BUILDING PRACTICE, IN 2016, THE DEMOCRACY COLLABORATIVE PROVIDED GUIDANCE, EDUCATIONAL AND TRAINING PROGRAMS, RESEARCH, AND PROGRAM SUPPORT TO COMMUNITIES ACROSS THE NATION WHO ARE SEEKING TO DEVELOP COMMUNITY DEVELOPMENT INITIATIVES THAT AIM TO PROVIDE OPPORTUNITY FOR DISADVANTAGED INDIVIDUALS AND DISINVESTED NEIGHBORHOODS.
